

## CCHRG Drawing Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE NUMBER OF ENTRIES.

1. **ELIGIBILITY:** CCHRG Drawing ("**Drawing**") is open only to legal residents of Massachusetts who are at least eighteen (18) years of age or older as of August 22, 2012. All employees of CCHRG ("**Sponsor**") and their immediate family members (spouse, parent, child, sibling and their respective spouses) and those living in the same household of each (whether legally related or not), are ineligible to enter or win the Drawing. All applicable federal, state and local laws and regulations apply. Void where prohibited by law. Entry in the Drawing constitutes your full and unconditional acceptance of these "**Official Rules**".

The drawing will be conducted by Sponsor, the judge of the Drawing, whose decisions on all matters relating to the Drawing shall be final and binding. At the sole discretion of the Sponsor, disqualification, forfeiture and the selection of an alternate winner may result from any of the following: (1) potential Winners' failure to respond to notification within ten (10) days after its transmission; (2) the return of an email notification as undeliverable after three (3) attempts; (3) potential Winners' failure to provide Sponsor with satisfactory proof of age, identity and residency; (4) potential Winners' failure to validly claim the prize by October 21, 2012; (5) any other non-compliance with the Official Rules.
